- We are a little under budget with revenue \$9.000. Look at this year vs. last year, we are up \$6000. Doing pretty well. More contributions second half of the year, normally.
- In CD we've put \$50,000 from restoration fund, so it's up to \$100,000
- To sum up: Giving: 10% below budget; 5% above last year Expenses slightly below budget, but some of this is timing related. No significant deviation from budget for the year is expected. Q2 YTD RECAP Central Builds has raised \$60,638 against a \$120,000 target Reasonable first half and running well ahead of last year, but still below budget

ADDENDUM: POTENTIAL CHANGES

This short addendum report is to inform you about some changes the deacons have been talking through recently, in order to generate discussion. **These are not proposals, so there will be no voting on these.** This is for discussion purposes only, as we'd like to hear the congregation's thoughts on these ideas.

The first idea to discuss is about the quarterly business meeting (QBM) cadence. We've observed that, over time, attendance and engagement in the QBMs have decreased for a variety of reasons. Regardless of the reasons, we've discussed shifting from quarterly to semi-annual (2/year) or annual (1/year) business meetings, and then calling additional special business meetings as needed (when a large decision needs to be made/voted on, or there is an issue in the church that is significant enough to require a special meeting). The mechanism for callings special business meetings is already in place, and would stay the same (pastor or clerk call meetings, per VIII.3). The thinking here is that it will drive up engagement/attendance in fewer meetings, as well as for any special meetings. A quarterly financial report would still be distributed, along with any important updates.

To make a change like this, we'd need to amend the constitution to reflect language like this (VIII.3 - which is currently mislabeled as 2):

The annual business meeting shall be held in January for the purpose of receiving the annual reports of individual officers, boards and committees of the church, the election of officers, and the transaction of such other business as is proper to come before this meeting. Quarterly business meetings shall be held in April, July, and October. [If we decided also on a semi-annual meeting, "A Semi-annual business meeting will be held in September" would be added here.] They can be held on Sundays or Wednesdays. Financial reports, as well as important updates, will be sent out quarterly in April, July, and October.

The next set of ideas have to do with updates for the constitution, which was written with a different staff situation in mind, to reflect the current staffing structure and be more flexible for the future.

The first idea here is to formally place all pastoral staff under the auspices of the Pastoral Relations Committee (PRC), as well as under the supervision of the Board of Deacons. Under VIII.6a.F for the PRC, it would reflect "all pastoral staff" language, rather than the ambiguity it currently shows. This change will ensure that the congregation knows that the PRC is a liaison between itself and all pastors (not just the lead pastor), as well as provide a review of all of the pastoral staff's compensation, performance, etc.

The second idea here is to rewrite VIII.E to place the position of our Next Generation Pastor under the supervision of the Board of Deacons, with support from the Board of Christian Education. Our current situation is not tenable, where one person (Rebecca) fills the role of Sunday School Superintendent and Youth Director – and serves on the board that is responsible for hiring and supervising her. In our view, it makes sense for a pastor to serve on and/or chair the board in their area of focus (in this case, Christian Ed), but to be supervised from the Deacons. Input in their supervision would be sought from the Board of Christian Ed, for instance. In addition, specific title language would be updated to something more general and/or flexible.

BOARD OF TRUSTEES REPORT

Completed Projects

- Atlantic Highlands Garden Walk Thanks to all the hard work that Karen and Bob Ruddy did planting, growing, trimming, and watering our gardens, our participation in the Garden Walk was a great success. We had 60+ visitors to our garden and a lot of them came with us inside to see our beautiful building. It was a great experience for us as well.
- Roof repaired There was a severe windstorm which damaged the roof in the middle of the sanctuary. The roof was repaired and all the shingles in that area were checked and re-nailed as needed. The roof flashing along the windows in Fellowship Hall was also checked and was sound, so the leak in the ceiling was coming from the windows.
- Ceiling leak -Fellowship Hall. I contacted Alpine's V.P. (Dave Scaturro) and he sent a team to glaze and caulk the windows. In addition, I also asked Dave to look at the original quote for the shingles replacement and update it for current costs, noting any increase due to tariffs or increased labor expense.
- Allen worked with Huff Masonry to complete the rebuilding of the step for the entrance on the driveway side of the Church has been repaired.

Projects in Progress

- Part of the basement is being refreshed, including painting and improvements, bead boarding, furniture, lighting, etc. It is nearly completed with the finishing touches to be completed soon. The project was a CBC team effort and showed how well we all work together for a common goal. The Church thanks you all for your hard work.
- Planning for the shingle replacement continues and the fundraising (Central Builds) is underway. We now have collected almost \$70K. The updated quote from Alpine will give us a more accurate target goal. Thank you for your continued support in helping to keep our beautiful and historic Church in great shape.
- Trustees are working towards upgrading door locks for child safety, as well as installing additional stair railings for safety and enhanced use.
